




Overview



The third round of BHBH Program funding will provide \$265 million to county behavioral health agencies that have a BHBH Program contract executed under the first round of funding.





Purpose: expanded implementation of bridge housing services for Californians experiencing homelessness and who have serious behavioral health conditions (serious mental illness and/or substance use disorder)

Application open	Friday, February 2, 2024	
County BHA applications due	Wednesday, April 10, 2024 – 4:00 PM	
County BHA conditional awards announced	July 2024	
Contracts/contract modifications executed	Within 60 days of county BHA's receipt of initial contract/contract modification language	



Who Can Apply for Round 3?

- » Round 3 is competitive funding for County BHAs only.
- » Eligible county BHAs must have an executed contract for BHBH Program Round 1 funding prior to the application deadline of April 10, 2024.
- » Two Tracks:
 - Track 1: BHBH Operations Strategic Enhancements (Required)
 - Track 2: BHBH Start-up Infrastructure (Optional)

*Note: Tribal Entities RFA Round 2B was also just released



Award Process

- » Successful applicants will be notified by email of a conditional award
- » All award decisions are final
- Contracting process may entail either a contract modification to the county BHA's existing BHBH
 Program contract or a new contract with AHP

Bridge Housing

Tracks and Allowable Expenditures Reminder

» Track 1: Operations

- Shelter, interim housing, rental assistance programs, and/or auxiliary funding for assisted living and housing navigation
- Up to 5% may be spent on outreach and engagement

» Track 2: Start-up Infrastructure

- The purchase and renovation of existing structures
- Must include a Track
 1 application to support operations

Application Questions: Track 1 BHBH Program Operations Projects

- » Applicant organization information
- » Application summary (up to 300 words) for public use
- » Experience (including accomplishments achieved through BHBH Program Round 1 funding to date)
 - Round 1 milestones/successes
 - Bed-nights provided and unduplicated individuals served
 - Status of start-up infrastructure project





Application Questions: Track 1 Operations Projects

- » Proposed strategic enhancements
 - Goals/objectives
 - Categories applying for
 - Total bed-nights anticipated
 - Is this an expansion of a BHBH Round 1 project, new, or both?
 - Timeline of milestones
 - Outreach activities
 - Description of housing navigation to be provided





Application Questions: Track 1 BHBH Program Operations Projects

- » BHBH Program Requirements
 - PWLE, Housing First, CARE Program participants, and Emergency Solutions Grants Minimum Habitability Standards/CoC Housing Quality Standards
- » Additional questions
 - Would you consider further expansion of BHBH in your community if DHCS were to make additional funds available for that purpose?
 - Do you anticipate needing additional funds to serve the CARE Program population?





Application Questions: Tracks 1 and 2 Operations Projects

- » Bonus Points: Serving Special Populations
 - People at risk of being in or exiting the criminal justice system
 - Children and youth involved with the juvenile justice system or the child welfare system
 - People with a primary diagnosis of substance use disorder (SUD).
 - Counties that did not receive BHBH Program Round 1 funding
 - Collaboration with a Federally Recognized Tribe or Tribal entity
 - Round 1 bed availability (Track 2)

Track 2: Start-Up Infrastructure and Requirements

- » County BHAs applying for this funding must demonstrate that they can support the corresponding operations. Therefore, those counties must also meet the requirements outlined in Track 1, in addition to:
 - Completing all bridge housing start-up infrastructure activities and making beds available within 1 year of contract execution
 - Limiting costs to a maximum of \$75,000/bed
- » Applicants needing less than \$25,000 for minor renovations or applications may request these funds as a Track 1 direct cost instead of applying for Track 2.





Application Questions: Track 2 Start-up Infrastructure Projects

- Briefly describe each proposed site, the proposed start-up infrastructure necessary, and any work completed to date.
- When will these beds be made available?
- Provide a BHBH Program Plan Section 3: County BHBH Program Start-Up Infrastructure Round 3 Supplement, including all project details.*
- If your operations application is selected for funding, but your start-up infrastructure application is not selected for funding, how would your county adapt its plans?

Completing the Application

- » You will complete the application in a fillable form on an online portal hosted by SurveyMonkey Apply.
- » **Round 3 is competitive:** County BHAs must respond to all questions.
- » Proposals must clearly describe the rationale for the selection of the chosen intervention(s).
- » Applicants must complete the BHBH Program application and submit it only through the SurveyMonkey Apply BHBH Program Round 3 portal.





Completing the Application

- » Before beginning the application, please review the application questions in RFA Attachment D.
- » Budget instructions can be found in RFA Attachment E.
- » The budget must use the Excel template accessible on the BHBH Program website. A budget narrative is also required.
- » You will receive a confirmation upon application submission. Note: if you do *not* receive an email, make sure you fully submitted the application.
